BYLAW NO. 8261

A BYLAW OF THE CITY OF REGINA TO CONTINUE THE BOARD OF POLICE COMMISSIONERS FOR THE CITY OF REGINA

WHEREAS <u>The Police Act</u>, R.S.S. 1983 c. P-15 requires the Council of the City of Regina to establish a Board of Police Commissioners.

AND WHEREAS the Council of the City of Regina deems it desirable to provide for and set forth the powers, duties and responsibilities of The Regina Board of Police Commissioners, the Chief of Police of the Regina Police Service and the Civic Administration insofar as matters of policing are concerned.

AND WHEREAS Bylaw No. 5456 of the City of Regina established a Board of Police Commissioners for the City of Regina.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1. The Board of Police Commissioners in and for the City of Regina is hereby continued.
- 1.1 This Bylaw may be cited as <u>The Board of Police Commissioners Bylaw</u>. (#9803, s. 2, 1996)
- 2. In this Bylaw:
 - (a) "Board" shall mean The Board of Police Commissioners in and for the City of Regina.
 - (b) "Council" shall mean The Council of the City of Regina.
 - (c) "Chief of Police" shall mean the person appointed by the Board as the Chief of Police for the Regina Police Service.
- 3. The Board shall consist of seven members, as follows:
 - (a) the Mayor;
 - (b) two members of Council;
 - (c) four citizen members, at least one of whom is of Indigenous ancestry.
 - (2) The members of the Board, other than the Mayor, may be appointed annually for a two-year term from January 1 of the year of appointment to December 31 of the year following appointment.
 - (3) Council may reappoint a member of the Board for a further term.

- 4. The Board shall be solely responsible for the provision of policing services within the City of Regina and shall have and exercise all the powers, authority and duties as provided in <u>The Police Act</u>.
- 5. The Board may make such rules and regulations for the governing and administration of the Regina Police Service as it deems necessary and appropriate.
- 6. For greater certainty, it is hereby recognized that:
 - (a) The Chief of Police shall be the Chief Administrative Officer of the Regina Police Service and shall be directly responsible only to the Board for the discharge of the powers, duties and authority conferred upon him.
 - (b) The duties and responsibilities in respect to the position of the City Manager as set out in Bylaw No. 7337 shall not be deemed to empower the City Manager, acting on his own initiative or anyone acting on his behalf, to have, perform, do or direct any act or matter that would to any extent whatsoever encroach upon the powers, duties and authority conferred upon the Chief of Police.
 - (c) The City of Regina shall continue to provide services to the Board upon such terms and conditions as are agreed upon between the Board and the Council.
- 7. The Council, or Executive Committee of Council, shall request the Board to meet with it at least once each year to discuss annual budgetary preparation and such other matters as the Board and Council may deem necessary or desirable for the provision of policing services in the City of Regina. - 7.1 On or before December 31 in each year the Board shall submit to the Council, for the Council's approval, the Board's estimates of all moneys the Board requires for the next fiscal year for the Board and Police Service. (#9324, s. 2, 1992; #9803, s. 3, 1996)
- 8. The police force of the City of Regina shall continue to be known as the "Regina Police Service".
- 9. Bylaw No. 5456 of the City of Regina is hereby repealed.
