Dan and Council,

I'm connecting today to express my enthusiastic support for the amendment regarding Fossil Fuel Advertising that Dan made to Executive Committee today.

As somebody who is invested in the growth of my community, I understand the important opportunities that sponsorship and naming rights allow for our City. The City of Regina's advertising policies allow for Regina's to have access to meaningful programs, great social support organizations, and more. It's for this reason that I am commending those who voted in favour of this amendment, because it is a risky move... placing limits on fossil fuel producers and sellers to advertise with our City potentially means a lot less investment.

It is exactly because I'm invested in the growth and wellbeing of my city that I am so excited about this amendment. When fossil fuel companies advertise and promote their industry, they are often sanitizing and minimizing the disastrous effects that fossil fuels have on our environment and on vulnerable communities who are most impacted by extractive industries.

Our City should be collaborating with and inviting partnerships from companies that have the well-being and health of our environment and our community as part of our shared values. The City has made a commitment to be a sustainable city by 2050, and it is impossible to reach that target without making tangible (and often difficult!) decisions to limit the reach of fossil fuels in our community.

I've heard many folks concerned that this is an attack on energy workers in Regina. I quite adamantly disagree and somewhat chuckle at the irony... the City of Regina, last year, when energy workers were locked out by the Co-op Refinery, refused to intervene and protect workers from being mistreated by their employer. And the Co-op's ability to advertise and position itself as a great company allowed them to downplay the far reaching consequences that the lockout had on energy workers. If our City truly wants to support energy workers, we must move forward and advocate for policies that incentivize or push energy companies to move to creating more sustainable jobs that won't disappear as we fight against climate change.

I've also heard that many councillors have argued that fossil fuel producers are moving to greener forms of energy, and that therefore, this is unfairly targeting them... but I would argue that this is the City creating more incentives for companies to recognize the immense value that green energy can contribute to their operations. Could you imagine if every City in Canada banned advertising from fossil fuel producers? How amazing would it be if fossil fuel companies all began moving to greener energy, therefore justly transitioning oil and gas workers to more sustainable jobs, because they couldn't have partnerships with municipalities without doing so?

I'm desperately hopeful that this motion will pass at Council, and I want to express my utmost thanks to those who voted in favour of this at Executive Committee.

We are appreciative of being able to live and work in the city. I also appreciate all the counsellors doing what can be thankless job at times and largely donating their time to the city and their constituents.

I am grateful that we live in a city, province and country in which we have a range of opinions and are able to have debates on items such as fossil fuel sponsorships for city facilities. However, for a variety of reasons I believe the timing and decision reached at the executive committee is not ideal.

A cynic could argue this is a way for some council members to be seen as doing something without actually addressing their concern. If members were wanting to have an impact within Saskatchewan they could engage with oil and gas companies operating within the province. Most large producers have sustainability officers whom would welcome dialogue with local politicians and would discuss measures taken or suggestions to reduce carbon intensity, with many having the same net zero targets as municipalities and other industrial companies. Instead of attempting to ostracize emitters, one could engage with them as presumably the largest carbon impact/reduction would come from working with those with the largest baseline emission levels?

This also strikes me as being tone deaf. One of the largest producers in Saskatchewan (Whitecap Resources) which has a significant presence in SE Sask. and utilizes many direct and indirect services and products throughout the province (including within Regina) has negative emissions intensity (as measured by tonnes of CO2 per barrel of oil). If council engaged with stakeholders in the province such as Whitecap, that could have been a teachable moment. Although not explicitly targeted in the proposed sponsorship ban, many of these ancillary companies that work directly or indirectly with oil and gas companies may not feel especially charitable to the City of Regina at a time when all levels of government are under financial strain. Most taxpayers and businesses aren't ideological, they want good governance. This doesn't strike me as good governance to potentially deprive city run facilities of financial resources when the city may have difficulties fulfilling its financial obligations and future capital requirements.

Lastly, this also strikes me as being unnecessarily divisive. 28(1), this is akin to one sibling striking another sibling unprovoked. Even in a decimated state, the industry is almost unparalleled in the province in terms of economic impact (employment, capital spending, exports, direct and indirect tax/royalty payments, etc.). Why would council choose to propose a policy (whose effectiveness is debatable) that is likely to alienate a large segment of its electorate/tax base, neighbouring RMs/municipalities, and other levels of government? A cynic may say this is akin to a Trump dog whistle. I realize there are multiple priorities that council can work on

simultaneously, however I would suggest council focus on unifying causes which they can have a measurable impact on.

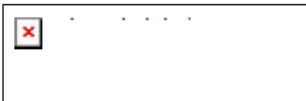

I do understand it is not permanent, and is being pushed to next Wednesday's meeting, so I wanted to provide my input.</p> <p>28(1)</p>
	<p>While I respect the ideas behind this amendment, it was poorly thought out and comes from a place of personal beliefs. If you need some inspiration on how to accept sponsorship dollars from so-called "controversial" companies, I recommend contacting the Saskatchewan Science Centre and asking how they handled taking money from Monsanto to build the Agri-Land exhibit. Maybe have a look at the Edmonton Science Centre, who took money from a large oilsands company to build a 2000 sq. ft. exhibit dedicated to renewable resources. Science Centres across the world have build policies to handle sponsorship dollars from private companies that make profit off of fossil fuels.</p>
Your Message	<p>I live in Ward 7, specifically the North East Community, where 20% of our residents live below the poverty line. They attend our Community Association events to participate in family activities at no charge, they send children to our after-school program to have something to do, and we feed them at several events throughout the year. Some of the children that come to these events do not have food security at home, and our dollars goes to getting food into bellies of our residents. Restricting sponsorship/advertising dollars from companies based on ideals hurts the people in our community who NEED these city services.</p> <p>If you want to show progress, why not accept sponsorship dollars and dedicate a percentage to funding sustainability education? Or for free bus passes for low-income citizens? Maybe it could go to Community Garden Initiatives to create green spaces and feed people in the city? An industry, I might add, that has more economic purchase by way of jobs, royalties, taxes, etc. than the fossil fuel industry. She also relies on fossil fuel income as part of her household income.

I'm sure you've received a lot of emails about the "controversial" city council motion, but here's another. (I remind myself I should email my elected officials to show support, too, not just when I'm mad about something).

I admittedly don't know every detail of this motion or the potential consequences, but I am [28\(1\)](#) and thus do understand the strategic and social implications of sponsorship hidden behind what is designed to look like good will and community building. This motion spurred an interesting conversation among my colleagues, and I thought about the potential of this situation being something we could face in the future. I like to think I wouldn't be offended if this happened to us. It isn't exactly a secret in our industry that we have room to improve.

I don't think that this should be as controversial as it is, and although I just admitted to not knowing all the details, I also feel the arguments against it are rooted in misunderstanding and fear. But beyond the specifics of this particular motion, I believe that our city council should be able to make decisions without receiving threats from our Premier, and that clearly hasn't happened. I am, once again, disappointed by Moe. It's a theme for me lately.

I hope his threats and the resulting mess I'm sure he stirred up hasn't been too discouraging to you or the other councillors who voted in favour of the motion. Thank you for continuing to think about a better future for our city and having the courage to stand up for it.
