BYLAW TO PROVIDE FOR THE CLOSURE AND SALE
OF THE LANE ADJACENT TO
1200 BLOCK ALBERT STREET

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

- 1 The lane described as follows is closed and may be sold:

“All that portion of the right-of-way backing the properties along 1200 Block Albert Street between 6th Avenue and 7th Avenue, as shown on the map attached as Appendix “A” and described as Surface Parcel Number 204008318 – St/L 995, Plan OLD 33, Extension 995.”
- 2 Bylaw No. 2023-6, being *The Bylaw to Provide For The Closure and Sale of A Portion of the Right-Of-Way Adjacent to 1200 Block Albert Street*, is repealed.
- 3 This Bylaw comes into force on the day of passage.
