Tom, Sheila, Adrian,

I have done a review of the scope of work (SOW) and offer the following comments

Depth of investigation - limiting the sampling to the top 30 cm will limit the land uses and tight ground disturbance policies will be needed to be protective.

Elimination of the ingestion pathway for food production will eliminate all rezoning from commercial, in addition a bylaw or other similar control will be required to prohibit and food production on the land (i.e. community gardens)

Elimination of the GW pathway for this study is valid, we will need comment and proposed monitoring to ensure that any impact from the former refinery operations are being monitored. There may be an opportunity to partner with CCRL on this and look at the Regina and Condi Aquifers from a regional perspective based on the history of the area.

I have no real issues with the vapour intrusion work as proposed.

All in all this is a very comprehensive look at the risk at the site and I look forward to the result. I have asked Dr. Steve Scilliano a soils toxicologist at the UOFS Toxicology Research Center to act as peer review for the work when completed. Steve is imminently qualified for the this work.

Please proceed with the the work and I trust that the work will be able to start in the couple of weeks.

The City of Regina appreciates your involvement, guidance and review of the Scope of Work involved in the assessment of City of Regina owned lands within the former Imperial Oil Limited (IOL) site. Managing human health and the environmental protection of lands is a priority to the City of Regina, as it is for IOL and the Ministry of Environment (MOE).

We respectfully requested you review the proposed Scope of Work for this project, and appreciate your feedback provided in a September 1<sup>st</sup> email to the City and IOL. To clarify, the intent of this Phase 2 investigative work is to determine immediate public health and environmental issues. Your comments offered on the Scope of Work suggest potential bylaws and future long-term land use controls may be in order. As regulator and owner of the lands involved, the City currently has regulatory controls in place to govern future land use decisions and will ensure that any development approvals take into account managing human health and environmental protection.

In addition, the soil sampling depth of 30 centimeters to determine any immediate risk was agreed to by both the City and IOL and deemed appropriate by MOE, with the common understanding that if soil sampling to this depth demonstrates an immediate risk, discussions on next steps and potential remediation will follow.

If this meets the requirements and satisfies your Ministry, please provide your concurrence in writing by September 23<sup>rd</sup> so the work can commence soon.
