

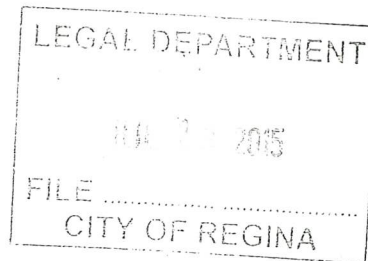

LEASE RENEWAL AGREEMENT dated this 6<sup>th</sup> day of July, 2015.

BETWEEN:

**THE CITY OF REGINA**  
(the "City")

- and -

**GROW REGINA COMMUNITY GARDENS INCORPORATED**  
(the "Lessee")

**WHEREAS:**

- A. The City has leased to Grow Regina Community Gardens Incorporated a portion of the Lands known as McLeod Park and comprising approximately 3.5 acres continuously since 2013 by virtue of a Lease Agreement dated January 18, 2013 and subsequent extensions.
- B. The City and the Lessee have agreed to renew the Term of the Lease for a period of 1 year under the terms and conditions hereinafter set forth.

**NOW THEREFORE** the parties agree as follows:

- 1. The Term of the Lease is hereby extended for a period of 1 year commencing July 24, 2015 and expiring July 23, 2016 (the "Extension Term").
- 2. During the Extension Term, the Lessee shall pay annual rent in the amount of \$1.00 to the City.
- 3. Provided the Lessee is not in default of any of the provisions of the Lease of this Renewal Agreement, the Lessee shall be entitled to a one year renewal or extension period.

4. In all other respects, the terms and conditions of the Lease shall continue in full force and effect. This Renewal Agreement shall be read together with the Lease and the parties confirm that, except as modified herein, all covenants and conditions in the Lease remain unchanged, unmodified and in full force and effect.
5. The Preamble forms an integral part of this Agreement.
