Bryan, Matt and Diana,

Congratulations everyone on Council approval of the MSA Agreement tonight. I walked into the Council Chamber just as they had approved it!

Please find attached the revised invoices for the MSA Agreement. My apologies for the confusion and delay.

Here is why I needed to update the invoices:

- I had included on one invoice 3 hours that were coded to the project, but were not intended to be billed. It was internal planning time.
- The allocation of time on the invoices was reversed for the GTH and City

Implications:

- Original GTH invoice was: \$8,555.00 > Revised amount is \$8,186.25
- Original City invoice was \$9,071.25 > Revised amount is \$8,555.00 (plus GST)

Good news – everyone pays a little less. The difference in the amounts for the revised invoices relates to specific conversations I had with each party of differing durations to gain context on the project from their perspectives at the outset. Diana and I had two conversations of a longer length. I thought it was fair to allocate the costs according to the time spent with each group. GST is applicable on the City invoice. GTH is PST and GST exempt as a creature of provincial government. Otherwise the amounts are the same.

Attached are the invoices and supporting spreadsheets for transparency between the two parties.

If you have any questions, please let me know! These are accurate now.

Thank you again for the opportunity to work together again on this project. Let me know if you would like me to review the draft legal agreements.
