# BYLAW TO PROVIDE FOR THE LEASING OF THE UNDEVELOPED PORTION OF VARIOUS RIGHT-OF-WAYS

# THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

#### Purpose

1 The purpose of this Bylaw is to authorize the leasing of the undeveloped portions of various right-of-ways for the purpose of accommodating billboard installations.

#### **Statutory Authority**

2 The authority for this Bylaw is section 13 of *The Cities Act*.

#### Lease Authorization

- 3 The locations described as follows may be leased:
  - (a) That portion of Saskatchewan Drive as shown in Schedule "A"; and
  - (b) That portion of South Railway Street as shown on Schedule "B".
- 4 This Bylaw comes into force on the day of passage.




