THE EMERGENCY MEASURES BYLAW, 2011

THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

Purpose

1 The purpose of this Bylaw is to establish a local emergency measures organization, appoint a local emergency measures co-ordinator and establish a local planning committee as required by *The Emergency Planning Act*.

Statutory Authority

2 The authority for this Bylaw is section 9 of *The Emergency Planning Act* and sections 8 and 55 of *The Cities Act*.

Local Emergency Measures Organization

3 There is constituted, established and continued a local emergency measures organization for the City which shall be the Emergency Preparedness and Business Continuity Branch.

Local Emergency Measures Co-ordinator

4 A local emergency measures co-ordinator for the City is hereby appointed as the Manager of Emergency Preparedness and Business Continuity.

5 The local emergency measures co-ordinator shall:

(a) Repealed. (#2018-60, s. 33, 2018)

(b) act as chairperson of the local emergency planning committee established pursuant to this Bylaw.

Local Emergency Planning Committee

6 There is constituted, established and continued a local emergency planning committee for the City, which shall consist of persons holding the following positions or their designate:

- (a) City Manager;
- (b) Manager, Emergency Preparedness & Business Continuity;
- (c) Executive Director, Citizen Services;
- (d) Director, Citizen Experience;
- (e) Executive Director, Financial Strategy & Sustainability;
