It is super news to know that you Jorin are the Chair of Dieppe/Westerra Community Association. The energy that you have brought to engagement sessions with us pre COVID and since speaks volumes about your commitment and your skill set. Your dedication to the work of the Association itself has been critical to it's success.

It was important to discuss the role of CAs in brief today and the option for Dieppe/Westerra to consider what it would mean to become more involved in development issues that impact the Westerra development.

I shared that of the 26 active CAs many have different perceptions of their role. Some focus exclusively on offering recreation activities. Others focus on social issues that impact residents in their area. Still other have hybrid interests. Maria and I shared that Councillor Zachidniak has an interest in the work of your CA. She has heard from at least one resident who has attempted to learn more about the work of Dieppe/Westerra. I know that you have reached out to a Westerra resident to serve on your board.

Such sessions were offered in the past and Maria and I can look into this further. The board would then be better informed to decide if a deep dive into planning is for them.
- 2. We could consider an engagement session geared to informing Westerra residents in particular about the work of Dieppe/Westerra CA and the work of Community Associations as a whole. We understand from you that the means of communication has been a paper newsletter hand delivered to the residents of Dieppe. (the last offered pre pandemic in 2019 (May, Sept. and Dec. 2019) There has been adhoc placement of the newsletter on the doors of residences and on Canada Post mail portals in Westerra with mixed results.

Yikes! I've been the manager of bylaw since January 2020 but I was in this role previously from May 2015 to January 2017.

I'm not sure about specific key messages but I can certainly provide you with some background information.

In terms of overgrown grass & vegetation (OG&V), that is regulated under the Community Standards Bylaw and my folks enforce this Bylaw on private property. With respect to OG&V, we deal with violations on private property both in response to complaints and proactively. The past couple of summers we have hired two additional casual BEOs to focus on OG&V violations in greenfield areas, such as Westerra.

The terms "overgrown grass" and "weeds" often get used interchangeably but they are actually two separate regulations. Weeds are declared as nuisance, noxious or prohibited under The Weed Control Act, which is provincial legislation. There is a bit of history when it comes to the Act which has found my shop being responsible for administering it even though the subject matter expertise to do so is not a core competency for a BEO. That aside, we do not proactively deal with violations of the Act on public property but if something is brought to our attention from a resident via a service request, then I have a standard email that I send to all of the directors who are responsible for managing city owned property.

For sidewalk snow removal, the Clean Property Bylaw was amended and new regulations came into effect January 1, 2022. As you may remember, we had a significant snow fall in 2021/22. As such, when my folks started the "education" process on January 1, there had already been a large accumulation of snow by then. When the amendments were brought forward, Admin committed to only educating so we did not issue any notices of non-compliance or remedy any violations. We will be issuing notices of non-compliance this year and remedying any properties that do not comply. If we have to clear the sidewalk, then the cost of doing so will be applied to the property tax account. This is our plan for the 2022/23 snow season and will be updating Exec tomorrow with the same information. In terms of enforcement, it is done in response to a service request as well as proactively when the BEO is in the field. We have an overall target of 30% of cases being proactive. We are doing work in 2023 to refine that number to bylaw and violation type.

Hi Carolyn and welcome back!!

I can't believe that it has been that long since we were on 13 Yikes! I've been the manager of bylaw since January 2020 but I was in this role previously from May 2015 to January 2017. I'm not sure about specific key messages but I can certainly provide you with some background information.

In terms of overgrown grass & vegetation (OG&V), that is regulated under the Community Standards Bylaw and my folks enforce this Bylaw on private property. With respect to OG&V, we deal with violations on private property both in response to complaints and proactively. The past couple of summers we have hired two additional casual BEOs to focus on OG&V violations in greenfield areas, such as Westerra.

The terms "overgrown grass" and "weeds" often get used interchangeably but they are actually two separate regulations. Weeds are declared as nuisance, noxious or prohibited under The Weed Control Act, which is provincial legislation. There is a bit of history when it comes to the Act which has found my shop being responsible for administering it even though the subject matter expertise to do so is not a core competency for a BEO. That aside, we do not proactively deal with violations of the Act on public property but if something is brought to our attention from a resident via a service request, then I have a standard email that I send to all of the directors who are responsible for managing city owned property.

For sidewalk snow removal, the Clean Property Bylaw was amended and new regulations came into effect January 1, 2022. As you may remember, we had a significant snow fall in 2021/22. As such, when my folks started the "education" process on January 1, there had already been a large accumulation of snow by then. When the amendments were brought forward, Admin committed to only educating so we did not issue any notices of non-compliance or remedy any violations. We will be issuing notices of non-compliance this year and remedying any properties that do not comply. If we have to clear the sidewalk, then the cost of doing so will be applied to the property tax account. This is our plan for the 2022/23 snow season and will be updating Exec tomorrow with the same information. In terms of enforcement, it is done in response to a service request as well as proactively when the BEO is in the field. We have an overall target of 30% of cases being proactive. We are doing work in 2023 to refine that number to bylaw and violation type.

Frequently Submitted Service Requests from Westerra Residents

TRANSIT

Why is Transit in Westerra only available on weekdays during morning and afternoon peak periods?

Route 1 Dieppe/Westerra-Broad North currently provides transit service to Westerra during peak times: 6 a.m. to 9 a.m. and 3 p.m. to 6 p.m., Monday to Friday. Service outside these peak times is not available because ridership in the Westerra area is not high enough. The minimum ridership required before additional service can be considered is 20 passengers per hour.

Why can't the City do a better job controlling weeds in the easements?

In 2022 the City seeded easements with drought tolerant turf and trees/shrubs. Whenever seed is used, there will be weeds present. In order to get the seed to germinate, consistent watering is required. Due to drought-like conditions during the first half of the growing season weeds were established. Once the temporary irrigation was installed, as well as timely rains, the seed did germinate and started to fill in much faster.

The City had been cutting the turf as well as the weeds, and have used hand pulling on two different occasions, however manual labour is very costly. As new grass is established, herbicide spraying is too risky as the turf is new and any spraying in this stage will have a negative impact.

In 2023, City crews will evaluate how well the turf endured the winter, reseed as necessary and use temporary irrigation until the turf can sustain itself. This is expected to be complete by the end the growing season in 2023. As the turf becomes better established, weeds should become less troublesome.

Why weren't easements replanted with sod, as it was originally?

To be successful, sod requires permanent irrigation which is not available in Westerra easements. Although the sod was originally planted according to specifications, sod should not have been planted at all because permanent irrigation was not in place. We've since changed our practices so that whenever sod is placed, irrigation must also be installed. The easement is a utility easement, which means it is maintained on a monthly schedule, and has no irrigation.

Why isn't the easement maintained as well as the park - Sereda Park, for example?

Sereda Park is classified as a Class B park which means it has a playground, recreation opportunities, irrigation, bbq's and tables, which are maintained on a weekly basis.

The easement is a utility easement, which has underground utilities. The classification on this easement is a Class C designation. This means that the open space is maintained on a monthly schedule, has no irrigation, playground or recreation opportunities.

What has the City done to replace dead trees in the easement and in the park?

This past June, trees were replaced in Sereda Park and are being watered regularly. An additional 47 trees were also added to the easement, in addition to the original landscape design. Crews have a watering schedule and will water these trees until freeze up. The trees will be assessed in the spring to determine if replacements are required.

Vacant lots are full of weeds and the property is not being maintained. What is the City doing about this?

The City has been in contact with the responsible developer. The City's Bylaw Enforcement Branch is aware of this and is monitoring these areas. This Branch acts on complaints as well as proactively. As the overgrown grass season is winding down for 2022, the Branch will ensure that Westerra is included in proactive enforcement patrols during the 2023 growing season.



WINTER MAINTENANCE

Westerra gets a lot more blowing snow than other areas. Does the City understand this, and are you providing the extra service we need?

When a wind event is forecasted, crews monitor and clear a priority list of areas prone to blowing snow which includes Westerra. A grader cycles the priority list to ensure access is maintained specifically for emergency vehicles.

This is an enhanced service to ensure access is maintained during these blowing snow events. The City will continue providing this service until the Westerra neighbourhood is further developed and the impact of blowing snow is reduced.

Why do City snowplows leave snow ridges at the entrance of the neighbourhood? This reduces visibility for traffic turning in/out of the area.

Our first priority following a snow or wind event is to plow the road as quickly and efficiently as possible so traffic can flow. This work requires a grader and snow ridges occur as a result. Once the plow is completed, we then begin removing snow ridges from problem areas and when road lane widths or driver sightlines are negatively affected.

We are aware of the issues with snow ridges in Westerra and this past winter, we removed excessive snow from this neighbourhood in the past season.

During a snow event, City crews keep major roads drivable by plowing snow and applying ice control at high-risk intersections. Our focus is on high-speed roads, those with the greatest volume of traffic, and emergency routes. This pattern continues until the snow has stopped falling.

Why not plant trees along Dewdney to prevent drifting in Westerra?

To effectively reduce blowing snow, a snow barrier needs to be roughly 100 feet away from a road. If trees were planted along the north side of Dewdney Ave, it would actually result in more drifting to occur along Dewdney Avenue and the entrances to Westerra.

Instead of planting trees or installing a fence, the City uses snow ridges built from the snow, as they are a better and more efficient solution to deal with blowing snow conditions on roads in open areas.

We will be able to build these snow ridges around the Westerra neighbourhood this year as we now have agreements in place with surrounding landowners. The snow ridges will be created early in the season in strategic places to minimize drifting on the road network. As well, we are working to arrange multi-year agreements to minimize the delays for building them earlier in future seasons.



WINTER MAINTENANCE CONT.

Will the City create snow ridges north of Dewdney Ave?

Currently we do not have permission to create snow ridges in the open area north of Dewdney. City is awaiting permission from the landowners. In the meanwhile, our snow plowing crews will work along Dewdney Ave more frequently to improve driving conditions on this section of road.

If there is an emergency in our neighbourhood, how can residents and emergency services respond when roads are blocked by snow?

We monitor perimeter neighbourhoods, including Westerra, during a snow event to maintain access specifically for emergency vehicles. In addition, emergency services are able to directly contact City staff if assistance is urgently needed. In this situation, all nearby resources would be redirected to assist.

Much like the highways around Saskatchewan, extreme weather conditions can make it unsafe for City snowplow operators to be on the road. Employees are then on standby until conditions improve enough to get back onto the road.

People cannot get in and out of Westerra and are constantly missing work after an overnight storm. How can you ensure residents can use the roads in the morning?

During blowing snow events, crews monitor perimeter areas including Westerra and clear main entrances when required. Clearing snow in time for the morning commute is all about timing and duration of the snow or wind event. If a wind event ends at midnight, crews are more likely to have plowed the area prior to 7 a.m. However, if the storm persists throughout the night and into the early morning, it may not be possible to have Westerra roadways cleared prior to 7am.

Why isn't the City using snow fences to prevent drifting?

A pilot study was conducted during 2020-2021 season in order to test the benefits of snow fences and snow ridges.

As a result, the City's Snow Ridge program has been found to be more effective and efficient as compared to Snow Fence program. Based on the outcome of the pilot study and previous positive experience with the effectiveness of snow ridges as compared to snow fences, the City intends to continue with the snow ridge program to alleviate drifting snow conditions on outer city roads.

The costs of snow ridges are significantly lower than snow fences. Snow fence installation, de-installation, storage and maintenance costs make the program very expensive. Snow fence installation and de-installation requires digging and frequent trips to the locations during busy seasons. Furthermore, snow fence installation requires that land be used for extended periods of time, which is generally not preferred by landowners.



WINTER MAINTENANCE CONT.

What will the City be doing better in the winter of 2022-2023?

- Snow ridges will be placed in area west of Horizons Way and for the center open area inside West Market, Canola and Horizons. This will provide some protection to West Market Street and Canola Avenue.
- Red Spring Street has been upgraded to a higher priority road which means additional necessary snow clearing operations. Reliable access to Trinity Manor will be improved.
- A commitment to ensure a minimum of one access is open to Westerra as long as it is safe to do so.
- Emergency services will be proactively contacted to ensure they are aware that winter road equipment is available and will assist if needed to get to an emergency.

I can't believe that it has been that long since we were on 13 28(1) Yikes! I've been the manager of bylaw since January 2020 but I was in this role previously from May 2015 to January 2017.

I'm not sure about specific key messages but I can certainly provide you with some background information.

In terms of overgrown grass & vegetation (OG&V), that is regulated under the Community Standards Bylaw and my folks enforce this Bylaw on private property. With respect to OG&V, we deal with violations on private property both in response to complaints and proactively. The past couple of summers we have hired two additional casual BEOs to focus on OG&V violations in greenfield areas, such as Westerra.

The terms "overgrown grass" and "weeds" often get used interchangeably but they are actually two separate regulations. Weeds are declared as nuisance, noxious or prohibited under The Weed Control Act, which is provincial legislation. There is a bit of history when it comes to the Act which has found my shop being responsible for administering it even though the subject matter expertise to do so is not a core competency for a BEO. That aside, we do not proactively deal with violations of the Act on public property but if something is brought to our attention from a resident via a service request, then I have a standard email that I send to all of the directors who are responsible for managing city owned property.

For sidewalk snow removal, the Clean Property Bylaw was amended and new regulations came into effect January 1, 2022. As you may remember, we had a significant snow fall in 2021/22. As such, when my folks started the "education" process on January 1, there had already been a large accumulation of snow by then. When the amendments were brought forward, Admin committed to only educating so we did not issue any notices of non-compliance or remedy any violations. We will be issuing notices of non-compliance this year and remedying any properties that do not comply. If we have to clear the sidewalk, then the cost of doing so will be applied to the property tax account. This is our plan for the 2022/23 snow season and will be updating Exec tomorrow with the same information. In terms of enforcement, it is done in response to a service request as well as proactively when the BEO is in the field. We have an overall target of 30% of cases being proactive. We are doing work in 2023 to refine that number to bylaw and violation type.

Based on the service requests it is a parks maintenance and snow removal "show" however transit will also be in attendance. Strictly your call. There will be a mechanism for any questions requiring follow up to be captured.

1. Q- The vacant lots are full of weeds and they're not being maintained.

A- The city has been in contact with the Developer of their responsibility. City Bylaw is aware of this and is monitoring these areas. Bylaw acts only on complaints as they arise. If no complaints are raised to Bylaw, they do not investigate.

Hi Carolyn and welcome back!!

I can't believe that it has been that long since we were on 13 Yikes! I've been the manager of bylaw since January 2020 but I was in this role previously from May 2015 to January 2017.

I'm not sure about specific key messages but I can certainly provide you with some background information.

In terms of overgrown grass & vegetation (OG&V), that is regulated under the Community Standards Bylaw and my folks enforce this Bylaw on private property. With respect to OG&V, we deal with violations on private property both in response to complaints and proactively. The past couple of summers we have hired two additional casual BEOs to focus on OG&V violations in greenfield areas, such as Westerra.

The terms "overgrown grass" and "weeds" often get used interchangeably but they are actually two separate regulations. Weeds are declared as nuisance, noxious or prohibited under The Weed Control Act, which is provincial legislation. There is a bit of history when it comes to the Act which has found my shop being responsible for administering it even though the subject matter expertise to do so is not a core competency for a BEO. That aside, we do not proactively deal with violations of the Act on public property but if something is brought to our attention from a resident via a service request, then I have a standard email that I send to all of the directors who are responsible for managing city owned property.

For sidewalk snow removal, the Clean Property Bylaw was amended and new regulations came into effect January 1, 2022. As you may remember, we had a significant snow fall in 2021/22. As such, when my folks started the "education" process on January 1, there had already been a large accumulation of snow by then. When the amendments were brought forward, Admin committed to only educating so we did not issue any notices of non-compliance or remedy any violations. We will be issuing notices of non-compliance this year and remedying any properties that do not comply. If we have to clear the sidewalk, then the cost of doing so will be applied to the property tax account. This is our plan for the 2022/23 snow season and will be updating Exec tomorrow with the same information. In terms of enforcement, it is done in response to a service request as well as proactively when the BEO is in the field. We have an overall target of 30% of cases being proactive. We are doing work in 2023 to refine that number to bylaw and violation type.

While I was away 28(1) , Councillor Zachidniak reached out to staff about a number of issues in Westerra. We were already supporting her on responding to several Parks issues, but she flagged concerns related to areas you are responsible for as well.

As part of those conversations she indicated her concern about a lack of a mechanism for residents to collectively share their issues and expressed an interest in holding a public meeting. She has now scheduled a community meeting for Monday, Oct. 3 at 7 p.m at Westerra Fields (in the community space in their rental centre).

While Bobbie was acting for me, she – along with Deb and the other directors in our division - discussed how to support her concerns and agreed to pull the Service Requests for the area to develop key messages for a meeting. The two main themes identified in the review of SRs are:

Parks Maintenance (Overgrown Weeds, Dead Trees & Grass etc.) Snow (Snow Rows, Wind Fence, Sight Lines, Snow Removal Plans etc.) Various topics related to intersection control, transit and bylaw complaints have been identified.
