(Maximum of 500 characters including spaces) This rehabilitation and expansion project involves: enhancing the existing earth berm and replacing the existing retaining wall that supports the North West Leisure Centre (NWLC) and Doug Wickenheisar Arena (DWA); redesigning and rebuilding the boardwalk to provide a safe environment to pedestrians in the area; and, relocate and enhance the existing play structure, making it accessible and creating a connection to the facility and the spray pad. 41. Detailed Project Description. Clearly outline the objective of this project, provide explicit details on the of the rehabilitation, renovation, repair or expansion work being planned, and identify any project risks and mitigation strategies. (Maximum of 4000 characters including spaces) The NWLC and DWA are located immediately south of and adjacent to Rochdale Park that surrounds a storm water detention pond. The open space between the building and the pond contains a concrete walkway, timber boardwalk and plazas and a small playground. There is significant change in elevation between the floor of the NWLC and the detention pond over a short distance, which required that a timber wall retention system be constructed when the facility was built in 1983 to maintain the integrity of the facility foundation and structure. This wall and supports have become unstable and possibly unsafe and needs to be replaced. The retaining wall is original from 1983 and is no longer capable of holding the pressure of the ground behind it any longer, and if it were to fail, it could impact pedestrians that use the adjacent path and/or cause a further significant and costly structural failure to the facility. A preliminary study has been completed by a geotechnical firm to determine the condition of the retaining wall and evaluate the potential risk for failure as well as provide recommendations for redevelopment, maintaining the functional use of the site. The report notes that the section of wall nearest to the NWLC has a noticeable lean away from the facility indicating the anchoring system holding back the wall has failed. The timber themselves have deteriorated and become an eyesore. The geotechnical review also included a slope stability analysis of the section of the earth berm between the facility and the stormwater retention pond. The results indicate that in addition to the retaining wall failure, there is general instability that suggests that a large block of earth has the potential of moving, starting from the floor of the NWLC and DWA, passing a considerable distance under the bottom of the wall and extending out to the retention pond. The existing wall system was never designed to withstand earth forces of this significance which were driven by the close proximity of the pond to the building. A newly designed and re-built retaining wall, earth berm, boardwalk and plazas at the NWLC would have the dual benefit of preventing damage to the NWLC and DWA facilities from slope failure as well as provide a pleasing aesthetic improvement

The NWLC is a neighborhood hub with an indoor pool, indoor arena, community rooms, and a small play structure with a new spray pad that is currently being constructed and will open in 2016. The NWLC and Doug Wickenheiser arena were constructed in the 1980s. A retaining wall that was constructed along the north side of the facility and is part of the foundation is in poor condition, is at risk of failure and is becoming a safety issue. There is also a boardwalk surrounding the storm water retention pond that is part of the multi-use path system that is also failing and beyond minor repairs. Furthermore, there is a playground that is situated at the NW corner of the facility. It is small, dated and most importantly, not accessible and not compliant with current standards. This project will address the safety and asset preservation for the retaining wall and boardwalk infrastructure elements as well as provide a new playground with accessible play elements. The newly designed retaining wall, playground, and boardwalk will improve the aesthetics of the area.

A new splash pad will be constructed in 2015 and open in 2016 on the south-west side of the NWLC. The intention is to relocate the playground and rebuild it on the south side of the facility so there is a connection to the pool, spray pad and green space and for all of the summer outdoor program amenities to be in one general area.

43. Describe the specific activities/costs Canada 150 Community Infrastructure Program funding would support and the Impact Canada 150 Community Infrastructure Program funding would have on this project. (Maximum of 2500 characters including spaces)

Cost of field work and slope stability analysis is \$50,000. Detailed design is estimated at \$100,000 with an estimated total construction cost of \$1.35 million. The cost to prepare the playground site, relocate and purchase new equipment is in the range of \$500,000, which exceeds the typical spending allocated to playgrounds in a single year. In a typical year, facility assets with failing infrastructure that is considered to be at an unacceptable level of risk for failure or public safety will tend to rank high for funding approval. So although it is reasonable to anticipate some degree of municipal funding to focus on the high risk components (earth berm, retaining wall, boardwalk), there is less certainty with respect to securing budget to address non-critical infrastructure like the playground.

Preliminary reports suggest that in doing the rebuild of the retaining wall, it is very likely that some or all of the existing playground site will become unusable.

The Canada 150 Community Infrastructure Program funding would allow the full scope of the project to proceed. What specifically that means for the community is the enhancement of a neighborhood hub facility. With the new addition of a spray pad to the southwest of the NWLC, there is a disconnection to the playground site in its current location. The Canada 150 funding would cover the costs incurred to relocate the playground so that there is a connection to the spray pad and green space. In addition, the new playground will have accessible elements, which the current play structure does not possess.

The project would involve the engagement of external consultants to assist with studies and design. Construction would be tendered and the overall project would be managed by internal resources of the Facilities Management Services department.

Q1 2016: Field investigation and further geotechnical analysis. The report would provide design parameters for structural design, recommendations to address slope stability and associated construction cost estimates.

Q3 2016: Detailed design of an enhanced earth berm, new retaining wall, boardwalk, plazas and playground. Working with a landscape architect, structural engineer, geotechnical engineer, and with input from Community Services, produce detailed drawings of the proposed construction.

Q1 2017: Tender and award construction in Q1 2017 so that construction can be begin spring 2017 and be complete prior to fall of 2017.
