# THE MUNICIPAL WARDS COMMISSION BYLAW, 2010

#### THE COUNCIL OF THE CITY OF REGINA ENACTS AS FOLLOWS:

# **Purpose**

- 1(1) The purpose of this Bylaw is to establish a municipal wards commission to review the boundaries of the wards in accordance with section 60 of *The Cities Act*.
- (2) This Bylaw provides the framework for appointment of members to the municipal wards commission in those circumstances when a review of the ward boundaries is required pursuant to *The Cities Act*.

### **Statutory Authority**

The authority for this Bylaw is section 58 of *The Cities Act*.

# **Definitions**

- 3 In this Bylaw:
  - (a) "City" means the municipal corporation of the City of Regina, or where the context requires, the geographical area within the city limits;
  - (b) "City Clerk" means the person appointed as City Clerk by Council pursuant to section 85 of *The Cities Act* and includes any person acting as his or her designate;
  - (c) "Commission" means the municipal wards commission established pursuant to section 4;
  - (d) "Council" means the council of the City of Regina;
  - (e) "member" means a member of the municipal wards commission.

#### Commission is established

The Municipal Wards Commission is hereby established.

# **Number and Appointment**

- The Commission shall consist of three members appointed by resolution of Council as follows:
  - (a) a Justice designated by the Chief Justice of the Court of Queen's Bench for Saskatchewan who shall act as the Commission chairperson;

- (b) the City Clerk; and
- (c) a representative of the University of Regina designated by the President of the University of Regina.

# **Term and Appointment**

- The specific appointments of the members of the Commission shall be made by resolution of Council whenever a boundary review is required pursuant to section 60 of *The Cities Act*.
- (2) The term of office for the specific members appointed by resolution of Council expires when their specific review of the ward boundaries is complete and the Commission files the report with Council as prescribed in section 61 of *The Cities Act*.

#### Quorum

Quorum for the Commission shall be a majority of the members appointed to the Commission.

# **Substitute and Temporary Members**

When a member of the Commission is unable at any time to perform the duties of his or her office by reason of absence or temporary illness, Council may appoint a temporary substitute member on such terms and conditions as Council may prescribe.

#### Vacancies

Any vacancy may be filled for the unexpired portion of the term of the person being replaced by the appointment of Council of another eligible person.

#### Removal

10 Council may, by resolution for any cause it considers sufficient, remove any member appointed to the Commission.

#### Meetings

- 11(1) The Commission will meet at the call of the chairperson.
- (2) The Commission may establish its own procedures.

# **Secretary**

The City Clerk's Office shall act as secretary for the Commission and provide administrative support as required.

#### Remuneration

The Commission members shall be reimbursed for any reasonable travel or other expenses incurred in relation to duties associated with the Commission.

  - (b) submit a report to Council identifying necessary changes, if any, to the current City ward boundaries.
