Earlier this morning, a tent at the encampment at City Hall was destroyed by fire.

Thankfully, there were no fatalities or injuries.

Over the past few days, Regina Fire and Protective Services had become increasingly concerned about the possibility of a significant fire at the encampment.

Today's fire confirms that the lives of those living on the encampment are at imminent risk.

Today, to best protect the lives of those living in the encampment, and in response to an imminent risk to their safety, I'm exercising my authority under the fire safety act.

We are now advising camp residents and organizers that they must vacate the City Hall Courtyard, and the areas alongside City Hall, immediately.

To be clear, this action is absolutely required, as the appropriate response to the imminent risk to the safety of those in the encampment.

Regina Fire and Protective Services have responded to three fires at the encampment over the past five days.

Fire Inspectors have been on site since the encampment first began, working to ensure fire safety regulations are respected.

Today's fire is a clear indication that compliance is not achievable.

This morning's fire was significant and of particular concern to me.

This was a fully involved fire.

It consumed an entire tent and its contents.

RFPS was required to extinguish the fire as it was not controllable by extinguishers.

Fire personelle could see the smoke from fire from north Albert Street.

Had it occurred in a more densely populated area of the encampment, I believe it would have caused loss of life.

I am convinced that decommissioning the camp is the best and only response to the imminent safety risk threatening the lives of those living on the Courtyard.

As previously stated, the camp will be decommissioned effective immediately.

To help ensure the decommissioning is safe and successful, residents are advised that City Hall will be closed to the public effective immediately. City Hall will remain closed on Friday, as decommissioning continues. We will m.

#### STATEMENT TO MEDIA

*The following statement, in whole or in part, can be attributed to City Manager, Niki Anderson.*

In response to an imminent risk of loss of life due to fire, the encampment on the City Hall Courtyard has now been decommissioned. For public safety, fencing will be temporarily installed around the green areas of the Courtyard and along the east and west sides of City Hall while cleanup is undertaken. The temporary fencing will remain in place until property repairs can be completed. City Hall will reopen to residents on Monday during regular business hours, and access to the front doors will be available from Victoria Avenue.

I'd like to thank Fire Chief Layne Jackson for prioritizing public safety in the midst of an incredibly complex situation. I am convinced his decision has saved lives. As the City's Administrative leader, I also want to emphasize the legislated separation of powers that allowed Chief Jackson to act urgently in response to an imminent public safety risk. Three fires at the encampment in less than a week established that camp residents faced imminent risk. Two more fires today provided more evidence that decommissioning the camp was absolutely necessary. I am deeply concerned by the public comments of at least one elected official, who claims that today's life-saving actions are an affront to the democratic process. To be clear, today's public safety action falls well within the provincially legislated authority of the City's Fire Chief. Elected officials who claim they should have been consulted about today's response are, in fact, placing the public at greater risk by inappropriately challenging public safety experts and eroding confidence in my Administration's ability to protect the residents of the City of Regina.

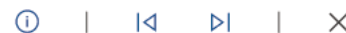

Good afternoon everyone,

We realize that many of your reporters are likely on site at City Hall now. Could you please share this information with them:

We wanted to reach out to make you aware of safety measures being put in place during the decommissioning of the camp this afternoon. Due to a variety of factors, including the presence of multiple items that could be used as weapons, we will not be allowing media or anyone not working as emergency services personnel to enter the perimeter.

#### How will this work?

At 1 p.m. everyone will be asked to leave the immediate area. Media is more than welcome to set up at the perimeter. Police Officers are aware of this and will make you aware of where you can and can not set up.

#### What is the perimeter?

The immediate streets around City Hall will be blocked off to both vehicle and pedestrian traffic. This includes the east and west bound lanes of Victoria Avenue from McIntyre to Smith Street, south to 12<sup>th</sup> Avenue. Media is welcome to set up along the west sidewalk on McIntyre Street and the south east corner of Smith Street, as well as on the Boulevard on Victoria Avenue. Again, if you have any questions please ask the officers on the perimeter.

We thank you in advance for complying with this request. The area must be clear in order to safely carry out the work being done pursuant to the Fire Safety Act.

I have met many of you through the years and appreciate the time and effort that you have all put in to make our city better. **I wanted to take this opportunity to invite you all to an event being held tomorrow at noon at the City Courtyard.** There is a group of us Regina citizens who are concerned about the lack of transparency regarding events related to the City Hall encampment. Good afternoon everyone,

We realize that many of your reporters are likely on site at City Hall now. Could you please share this information with them:

We wanted to reach out to make you aware of safety measures being put in place during the decommissioning of the camp this afternoon. Due to a variety of factors, including the presence of multiple items that could be used as weapons, we will not be allowing media or anyone not working as emergency services personnel to enter the perimeter.

### **How will this work?**

At 1 p.m. everyone will be asked to leave the immediate area. Media is more than welcome to set up at the perimeter. Police Officers are aware of this and will make you aware of where you can and cannot set up.

### **What is the perimeter?**

The immediate streets around City Hall will be blocked off to traffic. This includes the east and west bound lanes of Victoria Avenue from McIntyre to Smith Street. Media is welcome to set up along the west sidewalk on McIntyre Street and the South east corner of Smith Street, as well as on the Blvd on Victoria Avenue. Access from 12<sup>th</sup> Avenue is also closed. Again, if you have any questions please ask the officers on the perimeter.

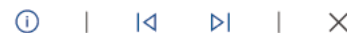

Just to give you an idea of where we are at, I thought I would send these suggestions and this info your way. This can be a starting point for our chat. I know that everyone has a lot going on and time is of the essence. The more coordinated we can be the better!

- Volunteers are holding a lunch and press conference at 12 pm
- Perimeter will be set up following this (1 pm) to keep everyone out while camp residents/volunteers and emergency officials clear the camp.
- Perimeter will extend from 12<sup>th</sup> Ave to East Bound lane of Victoria Avenue and from McIntyre to Smith. Media can film from sidewalks around the edge of the perimeter (west side of McIntyre and East Side of Smith up to a certain point to be determined)  
On Victoria Avenue they can film from the Blvd but not any closer.
- Do we want to set up a media staging area outside the perimeter with an on-site media liaison?
- This is a safety issue for media and everyone really (multiple weapons have been seen throughout the camp)
- I am suggesting that the city leads this
- I am suggesting the city has someone in media staging area
- I am suggesting we craft an email with the city for them to send to media letting them know of how things will go, as soon as possible. We can offer our legal team to help drafting this email.
- Depending on the level of police involvement throughout the afternoon, we will potentially have Deputy Chief Davies available to speak to the media at the conclusion of this.
