AUTHORIZATION TO TRANSFER DEDICATED MUNICIPAL RESERVE LANDS  
LOCATED AT 2606 GRANT ROAD

WHEREAS pursuant to section 199 of *The Planning and Development Act, 2007* the Council of the City of Regina wishes to authorize the transfer of certain dedicated municipal reserve lands located at 2606 Grant Road, being a portion of the lands legally described as Blk/Par MR15, Plan No. 101356893, Ext. 0:

THE COUNCIL OF THE CITY OF REGINA ENACT AS FOLLOWS:

- 1 The purpose of this Bylaw is to authorize the transfer of certain municipal reserve lands to the Board of Education of the Regina School Division No. 4 to satisfy the 1987 Central Lands Agreement.
- 2 The authority for this Bylaw is section 199 of *The Planning and Development Act, 2007*.
- 3 The lands dedicated as municipal reserve and legally described as follows:

As identified by the area shown outlined in red on Appendix "A"

are hereby authorized to be transferred.

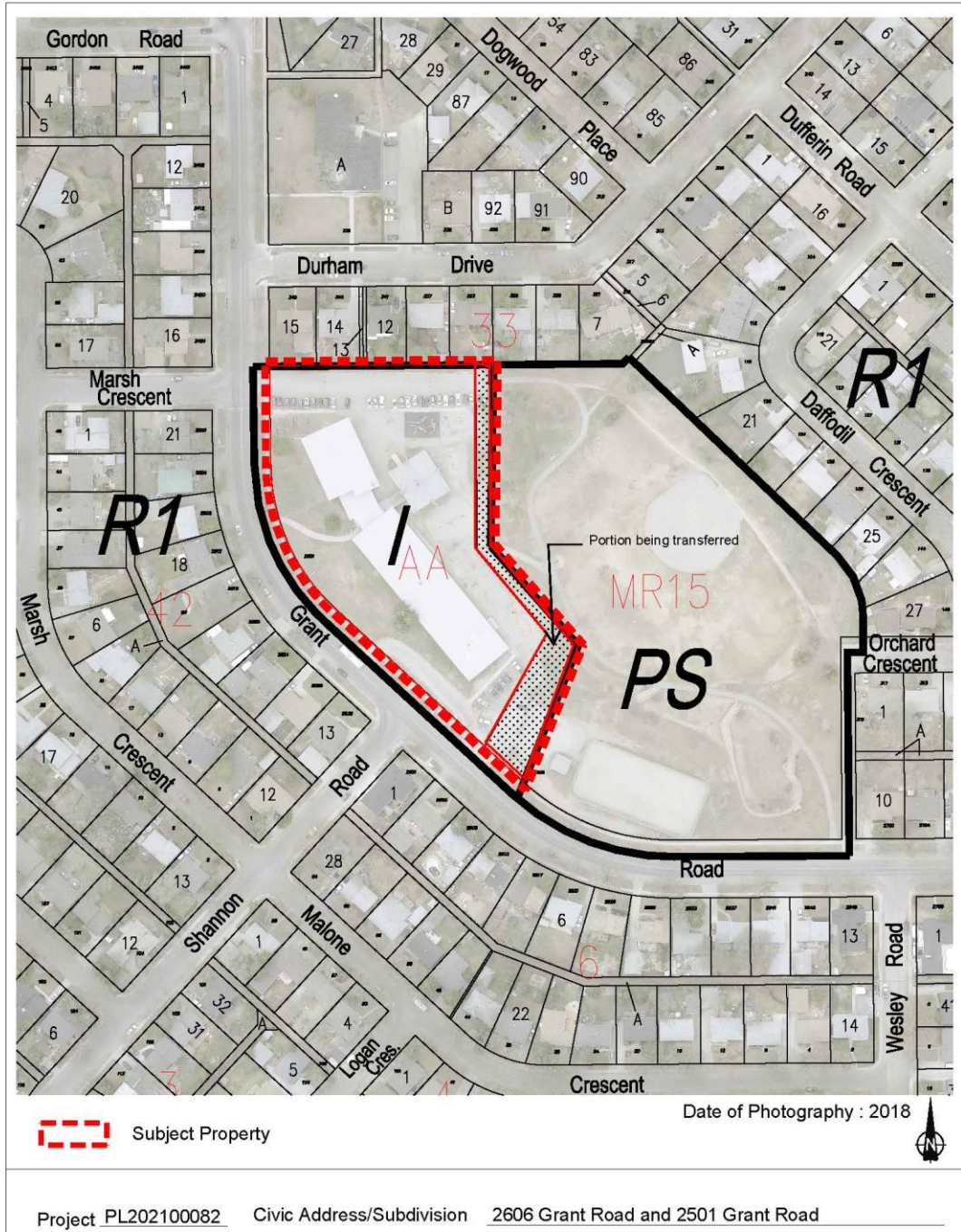
