Dear Mayor Fiacco,

I called your office today to learn more about Heterosexual Family Pride Day, having learned about it this afternoon by e-mail, when I received the article that follows. (Actually, I think I heard of it a couple of weeks ago, but assumed it was a hoax.) I called your office to find out who are the people in MY COMMUNITY who think this is a good idea. Who ARE these people? Your receptionist politely stonewalled me, so I still don't know. (She was very nice, and I'm not complaining.)

I am sending you the article below, because, although I am (currently) a married woman, a mother and a Christian, I find this Proclamation, and the whole idea of Heterosexual Family Pride Day, deeply disturbing, for reasons Michele Landsberg describes perfectly.

The Proclamation of Heterosexual Family Pride Day, with each of its debatable "whereas's", alerts me to the fact that I am living in a community that understands and is using Christianity in a way that assaults my understanding of Christian love. I fear the thinking behind this proclamation.

I worked for several years as the children's counsellor in a Regina shelter for battered women, and I can assure you that the "intact heterosexual family" very often does not "provide an excellent nurturing environment for children..." I saw hundreds of children from heterosexual families in turmoil. Some of the worst abuse of women and children was at the hands of "Christian" men who found Biblical justification for controlling members of their families with physical force. Often non-Christian men would cool off and think they had made a mistake. But the "entitled Christian men" often had more trouble recognizing criminal assault as such, and their damaged wives often believed in their hearts that they "deserved it". From many years of working in shelters, one of my more vivid memories is of a minister of a Christian church coming to the door of the shelter and demanding that we release to him, right then and there, a woman with an arm broken and eyes blackened by her husband. And her three frightened children. This was on the woman's third trip to the shelter, each time with more serious injuries. The minister argued that the husband is head of the family, I countered with "as Christ is the head of the church, so show me the passage that condones beating your wife."

But that kind of conversation is usually pointless. I have found it possible to ignore these people, and I like to "live and let live" whenever possible.

I write to you now to tell you I am sorry you signed this Proclamation, "ask[ing] our citizens to recognize this day." By asking us to recognize this day I can only assume you agree with the "whereas's". I would have hoped that, as the elected mayor of all Regina citizens, you would have exercised a dispassionate regard for the civil liberties of us all, and refused to condone the activities of a group whose sole purpose is to undermine the aspriations of another group.

As Landsberg's article illustrates and describes, this is not an event that will bring honour and admiration to Regina. I'm not sure it'll be great for tourism or industry, either.

When I first heard about it, the idea was so preposterous that I dismissed it as just another Internet hoax. Then my latest copy of Briarpatch

("Saskatchewan's independent alternative newsmagazine") arrived in the mail. Good old Briarpatch's enterprising editors had actually reprinted the entire, official announcement:

The office of the mayor of the city of Regina proclaims Monday, June 18, as Heterosexual Family Pride Day.

The long list of "whereas's" makes the mayor's orientation abundantly clear. Whereas the intact heterosexual family unit is ordained by God as clearly revealed in the Holy Bible, and whereas "large bodies" of research show that the intact hetero families provide excellent nurturing for

children, and whereas the i.h.f. provide necessary stability for the good of society, and whereas the i.h.f provides "sexual satisfaction for the men and women who are committed to them", and whereas monogamous husbands and wives have no reason to worry about AIDS or broken hearts (oh yeah?), Mayor Pat Fiacco asks citizens to recognize Heterosexual Family Pride Day.

My first reaction was a burst of hearty laughter; my second was a slight queasiness at the thought of the small-eyed, snake-belly-white kind of

homophobe who would come up with such a farrago of nonsense.

Smug majorities are given to this kind of thing. They lash back at any disadvantaged group that pesters them with demands, needles them into the painful exercise of thought or disturbs their placid enjoyment of their monolithic rightness, whiteness and entitlement.

The first stage of reaction is denial. Wife-battering? Child sexual abuse?

Systemic racism in Canada? I could cite you chapter and verse of the respectable commentators who swore up and down that none of these harms existed.<

The second stage of majoritarian panic is, pardon the expression, appropriation.

The same misogynists who insisted that there was no such thing as wife-battering soon began to change their tune: from a bellow to a whine.

"Me too!" they began to whimper. "Men are battered too." Despite the obvious idiocy of this claim --- women who are deemed "battered" are subject to a complex mesh of submissive conditioning, threats, intimidation, physical violence, crushed self-respect, terror and financial dependency, usually because of responsibility for the children --- the

wails of the copycat victim are heard world-wide.

In Cairo, where women can choose female-only subway cars to avoid gropers, a male lawyer is threatening to sue unless the city provides men-only

cars.

In Austria, where women earn one third of the male rate of pay, Herbert Haupt of the far-right Freedom Party is not only the minister of women's affairs ---he's also a backlash bozo who thinks there should be a men's

department . And in British Columbia, a shelter for men who have suffered "verbal or physical abuse" (cry me a river) had to close down for lack

of public support. The National Post was aghast at their plight.

Heterosexual Family Pride Day, however, is the ultimate in embarrassing acts of appropriation. Can you imagine the mind of someone who think he

has to strut the "pride" of heterosexual men? The smarmy language doesn't hide the all-too-obvious motives: to assert the supremacy of conservative family values, to denigrate the claims of the gay rights movement, and to try

to enshrine one Christian or "missionary" brand of sexuality as the only official and legal style of union.

Seems these evangelicals feel all shook up unless the state enforces their form of belief. Their idea of social stability, however, is just what

threatens us all. It creates the kind of parents who teach their children to hate and taunt their schoolmates who are children of lesbians or gay

men. It gives licence to the kind of thugs who would beat a Matthew Shephard to death because he was gay. It breeds the toxic intolerance that drives gay youths to a 30 per cent higher suicide rate than other teens.

Heterosexual "intact families" --- a tiny minority --- already bask at the top of the social -approval ladder. Surely that's enough legitimation for anyone. Besides, I just read in the New York Times that the divorce

rate in the evangelical Christian heartland of the U.S. is 50 per cent above the national average.

The patriarchal system isn't working any more, fellas! It's plumb broke.

Proclaim all you want, you're driving last century's model. Maybe, instead of copy-catting gay pride days, you ought to learn something from feminists, lesbians and gays about real love and commitment in the arms of equality.

On second thought, nah. Equality is one thing you can't fake.

A short time ago I sent you an e-mail in opposition to your proclamation of a heterosexual-pride day in Regina, and I asked for a response to my letter, but one never came. I wasn't kidding. I want a response. I'm giving you another chance to send a response, and I'll repeat for you basically what my first letter said.

So here is my question for you, Mr Mayor, and I want a response. Would you, as Mayor of Regina, proclaim a White Pride day? If your answer is "no", please explain why not, and what the difference is between a White Pride day and a Straight Pride day. This is a very simple question, and I want a response this time.

I will point out that I am saving our e-mail correspondence, and if I don't get a response this time, I will be informing the media and the gay and lesbian community organizations in Regina.
